Reduction of the statute of limitations

Agreement with a consumer on shortening the limitation period for the sale of used cars or used spare parts/accessories that are not digital products within the meaning of § 327 and § 327a BGB

Deviating from the legally regulated two-year limitation period, the contracting parties hereby agree on a limitation period of 1 year for the assertion of claims due to material defects and defects of title of the used purchased item/goods.

The agreement on shortening the limitation period to 1 year does not apply to damage based on a grossly negligent or intentional breach of obligations by the seller, his legal representative or his vicarious agent or in the event of injury to life, limb or health.

If the seller has to pay for damage caused by slight negligence on the basis of the statutory provisions, he is only liable to a limited extent: Liability only exists in the event of a breach of essential contractual obligations, such as those that the purchase contract intends to impose on the seller according to its content and purpose or the fulfillment of which enables the proper execution of the purchase contract in the first place and on the observance of which the buyer regularly relies and may rely. This liability is limited to the typical damage that was foreseeable at the time the contract was concluded.

The personal liability of the seller's legal representatives, vicarious agents and employees for damage caused by them through slight negligence is excluded.
